I am pleased to share this year's SKS Annual Giving Report, which recognizes and thanks all those who gave so generously to support St. Katharine of Siena School. I would like to express my thanks to Principal, Jeanne Mulvanerty, Board Chair, Ben Piazza, Home and School President, Alison Morris and Pastor, Msgr. Hans Brouwers. Also, Anne Condello and Elise Parisi have been exceptionally helpful to me. I extend my gratitude to all of them for their support in our fundraising efforts.

Since its inception six years ago, the SKS Annual Fund has raised over \$1.5 million, directly helping us close the gap in our operating budget, address deferred maintenance needs, and launch important new school initiatives. This year, we were thrilled to expand our donor base beyond current families and set a new record—raising \$517,000 for the Annual Fund.

In addition to this remarkable achievement, the SKS Endowment Fund, established just two years ago to help secure our school's financial future, raised another \$170,000, bringing the total endowment fund to over \$700,000. Managed by a dedicated committee of our SKS Board, the endowment is a critical pillar of our school's long-term planning.


As someone who holds this school close to my heart, I often say I could never fully repay what SKS has given me. This community, this mission, and this place will always have my deepest gratitude. Thank you for believing in SKS and for giving so generously from your heart. Your support makes a lasting difference.

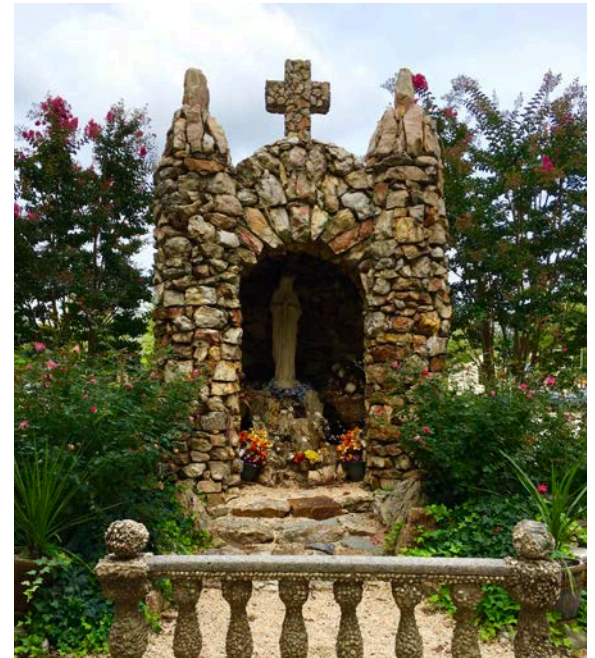

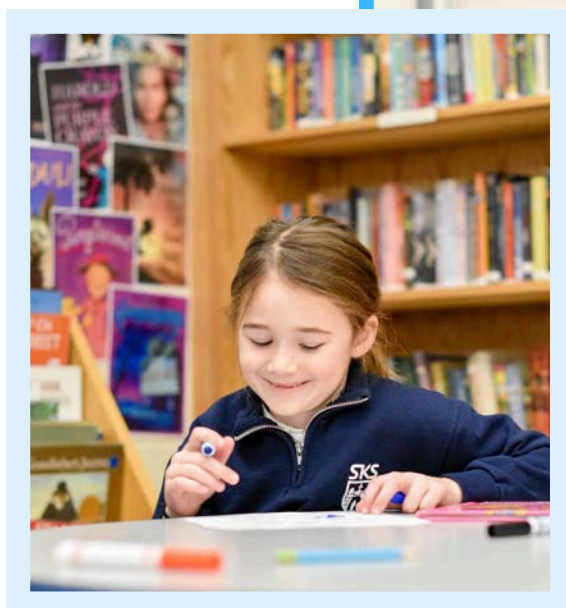
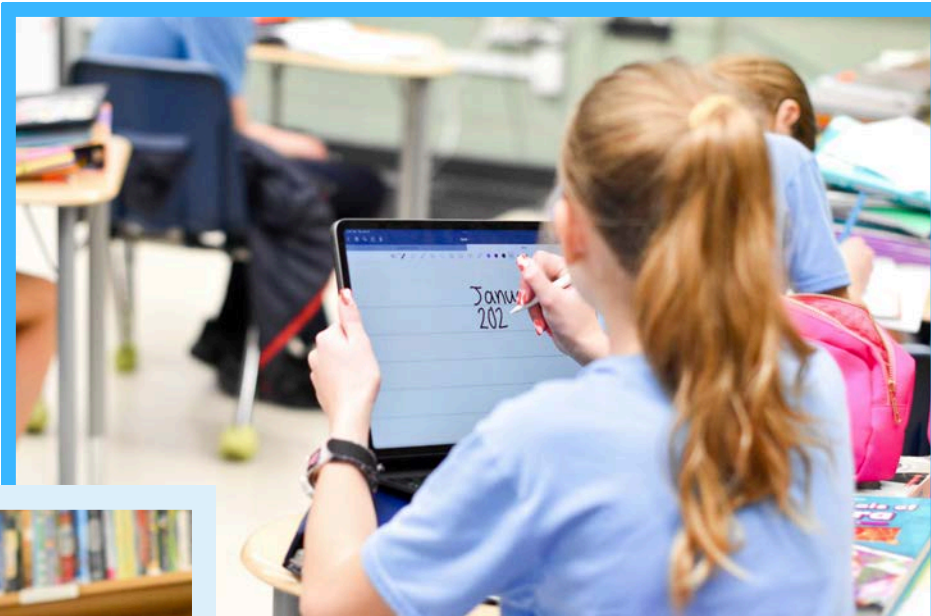
Educational Income Tax Credit
